to fulfill the legal requirement for 2 clock hours of ethics training by January 1, 2011. All you need is a computer with Internet access.

Registration fee: \$95. Elected officials may view this on-demand webinar with other board members or individually, for up to 60 days from the date of purchase. Upon purchasing the on-demand webinar, the registrant will receive an access link. This access link may be shared with your board members who are also watching independently, and access will be available for up to 60 days from the date of purchase.

Verifying attendance: The law requires the clerk to the governing board to maintain a record verifying receipt of the ethics education by each board member. The School of Government will not provide verification of attendance for the on-demand webinar. Instead, each elected official will be responsible for reporting their attendance to the clerk. Please click here for a generic form which may be used by clerks to verify attendance for ethics training via webinar, webinar ondemand, or other ethics training events for which the elected official is self reporting.

In keeping with the spirit of the new ethics law, and out of an abundance of caution concerning the legal requirements for board meetings, boards should probably give special meeting notice for live ethics training sessions, or the on-demand presentation of the webinar, if a majority of the board might be in attendance at the event.
