REPORT:

Superintendent's Report - Dr. Jackson presented his monthly report including the following items:

In addition to the normal advertisements, the January Board of Education Meeting was advertised via social media.

Dr. Jackson gave a brief update on the Leandro case.

Thanks to our partnership with Albemarle Boats, Colony Tire, Jimbo's Jumbos (Hampton Farms), and Regulator Marine, and in conjunction with the College of the Albemarle, we are excited about the launching of our new Career Essential Program for

seniors. Students will receive Continuing Education credit for this course, will visit the four businesses listed, will receive preferred interviews at those businesses, and have the opportunity for internships during and after the program. The program:

- will meet 4 days a week from February 3 May 14 (Monday Thursday)1:45 3:35pm
- consists of 8 hours face-to-face each week
- will be located on the Edenton COA campus
- will have field trips to businesses

An information session for seniors was attended by approximately 20 students.

A new communication vehicle has been launched to share our successes, a podcast named EdLeader. Educational Leadership is an ever-evolving opportunity to make a real and lasting difference in the lives of students, parents, and the community. The first episode highlighted the successes of our school district. The second podcast highlighted our newly named Regional Principal of the Year. Report from Joint Board of Education/Board of County Commissioners Committee on High School Replacement - Chairman Jordan, Mr. Browder and Mr. Clifton shared information with Board Members from the recent Joint Board of Education/Board of County Commissioners Committee Meeting on High School Replacement. The ownership of the Scout Hut and Tennis Courts was discussed. A motion was made by Mr. Browder to engage the school system's attorney to research the ownership of the various land parcels that make up the John A. Holmes High School campus and to work with attorneys representing Chowan County and the Town of Edenton to unify ownership of the property in the name of a single entity. A second to the motion was made by Mrs. Bunch. The motion carried unanimously.

Class Size Update - Dr. Sasscer, Assistant Superintendent, gave the Board an update on the school system's compliance with the class size reduction legislation and provided future projections for needed K-3 teachers.
