REPORT:

Child Nutrition Program Update - Mrs. Karen Tynch, Director of Child Nutrition, presented the Board with an update on the Child Nutrition Program and answered questions from Board Members.

Learning-Focused Instructional Initiative - Ms. Tanya Turner, Assistant Superintendent and Mr. Steve Wood, Principal of John A. Holmes High School, presented the Board with information about the Learning-Focused Instructional Initiative at John A. Holmes High School and answered questions from Board Members.

Edenton- Chowan Schools Strategic Plan - Ms. Tanya Turner, Assistant Superintendent, updated the Board on the system's progress on Goal One of the Edenton-Chowan Schools Strategic Plan and answered questions from Board Members.

Superintendent's Report: Dr. Jackson presented his monthly report including the following items:

Last summer, the Board of Education hosted a meeting with civic and religious leaders to share data census and demographic data about Chowan County. Upon learning of the number of children in Chowan County that were food-insecure, Pastor Chris Aydlet and the Outreach Committee at Edenton United Methodist Church formed a summer nutrition program that served 69 families and 166 children over the summer months.

The North Carolina Department of Public Instruction assesses and makes a compliance determination of each of the school systems and charter schools in the state. The Edenton-Chowan Schools Exceptional Children's Program earned the highest designation of "meets requirements".

Dr. Jackson was excited to share that both the John A. Holmes High School Women's Tennis Team and the Football Team won the Conference Championship. In addition, three student-athletes were chosen as the All-Area Student Athlete of the Year in their sport (tennis, cross-country, and football). Dr. Jackson also expressed his appreciation

to the community for the tremendous support that John A. Holmes High School and the football team received during the recent run to the State Championship game.

Dr. Jackson shared that he recently attended the Chowan Middle School Chorus, 6th Grade Band, 7th Grade Band, and 8th Grade Band Winter Concert at the North Chowan Recreation Center. Also, the John A. Holmes High School Chorus and Band recently performed in the high school auditorium. Vocal and instrumental music instruction is alive and well in our school system and are steadily improving.
