1:1 Digital Learning Device Sustainability Plan - Mr. Kerry Mebane, Chief Technology Officer, gave Board Members an update on the 1:1 Digital Learning Device Sustainability Plan.

Superintendent's Report - Dr. Jackson presented his monthly report including the following items:

As of June 4, 2019, the Class of 2019 has earned \$5,489,259 in college and university scholarships. This is the second highest total in school system history.

Among the Edenton-Chowan Schools Class of 2019, 48 Seniors earned 764 college credits while attending John A. Holmes High School. Briana Rodriguez and Ryan Tunney earned an Associates Degree before graduating from high school. Five additional students, Lilly Boyce, Jacob Forehand, Kyler Holmes, Michael Winebarger, and Dylan White all earned enough credits to enroll as a Sophomore in the University of North Carolina system.

Many of our students have earned enrollment into Honors Colleges in the universities in which they applied. Senior Amy Turner has been selected as an EC Scholar at East Carolina University.

Three Seniors have indicated they will be enlisting in the United States Military, Derrick Cross, Dagoberto Pacheco, and Josh Colon.
