Superintendent's Report - Dr. Jackson presented his monthly report including the following items:

Dr. Jackson recently attended the Ribbon-Cutting for the Sandy Ridge Outdoor Classroom, Garden and Trail which is between White Oak Elementary School and D. F. Walker Elementary School.

Work on the new Central Services Project is about two weeks ahead of schedule. Dr. Jackson recently approved a change order for the Central Services Project in the amount of \$418 to remove a one-way mirror between two offices. There may be two additional change orders forthcoming.

Since the last Board Meeting, Dr. Jackson approved an overnight trip request for the John A. Holmes High School Track Team to compete in the State Championship.

Graduation for the John A. Holmes High School Class of 2018 is scheduled for Saturday, June 9, 2018 at 7:00 pm.

The Class of 2018 earned \$6,741,027 in offered scholarships, including \$74,250 in local scholarships from community businesses, groups, and individuals. This breaks the previous record from 2015 by over \$2.4 million.

The Class of 2018 has also earned 769 college credit hours from COA and includes five students who have already earned their Associates Degree.

The Class of 2018 also led John A. Holmes High School to win the 2017-2018 Wells Fargo Conference Cup for the Best Overall Athletic program.

Career and Technical Education Plan - Ms. Casey Bass, Director of Secondary Education and Career and Technical Education, shared the Career and Technical Education Plan with Board Members and answered questions. A motion was made by Mr. Burroughs to approve the Teacher Contract list as presented. A second to the motion was made by Mr. Clifton. The motion carried unanimously.

Resolution Supporting North Carolina Whole Child Month - Dr. Jackson presented a Resolution Supporting North Carolina Whole Child Month to the Board for their consideration. A motion was made by Mrs. Elliott to adopt the resolution as presented. A second to the motion was made by Mrs. White. The motion carried unanimously.
