The meeting was called to order by John Guard and an invocation was given.

2 - July Quarterly Meeting - Dr. Jackson recommended moving the July Quarterly Board Meeting from July 18, 2016 to July 25, 2016 to allow Attorney Richard Schwartz to conduct board training at the meeting. The Board supported the recommendation.

3 - Superintendent's Report:

Edenton-Chowan Schools was recently recognized by the North Carolina Department of Public Instruction for being the first school system in the state to reach 100 percent participation on the North Carolina Teacher Working Conditions Survey. The school system received a check in the amount of \$1,000 that will be equally divided among the four schools.

Edenton-Chowan Schools Transportation Department has received a grant to install extended stop arm systems on five local school buses.

Due to a lack of enrollment, the opening of the new Pre-K classroom will be delayed for at least one year.

Recently, members of The Albemarle Sounds choral group presented checks in the amount of \$100 per school to each of the schools music teachers in support of the vocal music programs.

On May 14th, Chowan County student-athletes competed in the Special Olympics competition held at Northeastern High School in Elizabeth City, NC.

White Oak Elementary School and DF Walker Elementary School have received a \$10,000 Schoolyard Habitat Program Grant from the US Fish and Wildlife Agency. DF Walker has also received an outdoor classroom space to accompany the new wetlands project.

Dr. Jackson has contacted the North Carolina Department of Transportation (NCDOT) regarding the intersection of NC Highway 32 and Sandy Ridge Road. A study of the intersection was last conducted in March, 2014. The NCDOT has agreed to review the intersection again.

To date, the John A. Holmes High School Class of 2016 has received 300 college acceptance letters and over \$3.4 million in scholarships. Commencement Exercises will be held on Friday, June 10, 2016 at 7:00 pm.
