REPORT:

Report from Joint Board of Education/Board of County Commissioners Committee on High School Replacement - Chairman Jordan and Mr. Browder shared information with

Board Members from the recent Joint Board of Education/Board of County Commissioners Committee Meeting on High School Replacement.

NCSBA Annual Conference Information - Mrs. Sarah Hare, Board Clerk, provided information on the upcoming NCSBA Annual Conference. The conference is scheduled for November 18-20, 2019 at the Koury Convention Center in Greensboro, NC.

Superintendent's Report - Dr. Jackson presented his monthly report including the following items:

D. F. Walker Elementary School has been named North Carolina's National Title 1 Distinguished School in the category of high progress. D. F. Walker Elementary was one of two North Carolina schools chosen to be finalists for this prestigious award out of approximately 1,400 Title 1 schools across the state. D. F. Walker Elementary will represent the state during the 2020 National Title 1 Conference in Atlanta, Georgia in February.

The administrators of Edenton-Chowan Schools have selected Chowan Middle School Assistant Principal Ms. Makesha Spivey to represent them as the 2019-2020 Assistant Principal of the Year.

Mrs. Sheila Evans has been selected as the 2019-2020 Edenton-Chowan Schools Principal of the Year.

Mrs. Amanda Goodwin, Transportation Director, has researched the number of our students that live in town versus in the county. It was determined that of our 1,872 students, 735 live inside the Town of Edenton Limits (39%). 1,225 (65.4%) students live within the boundary that stretches from Wildcat Road to the River Bridge at Drummonds Point.

The annual PBIS celebration will be at the Aces football game on Friday, November 8th. Students will have the opportunity to parade down the track to be acknowledged for their good choices.

Dr. Jackson also reported to the Board that he approved an overnight field trip for the John A. Holmes High School Tennis Team to compete in the State Competition.
