MINUTES

The Edenton-Chowan Schools Board of Education met for the Quarterly Board Meeting on Monday, October 22, 2018, 6:30 pm at the College of the Albemarle Culinary Building with the following Board Members present: Chairman Gene Jordan, Vice Chair Jean Bunch, Ricky Browder, Gil Burroughs, Paul Clifton, Glorious Elliott, and Superintendent Dr. Rob Jackson. Joan White was absent.

The meeting was called to order by Chairman Jordan and the invocation was given by Mrs. Bunch.

The Pledge of Allegiance was led by Chairman Jordan.

APPROVAL OF AGENDA: A motion was made by Mr. Burroughs to approve the agenda as presented. A second to the motion was made by Mrs. Bunch. The motion carried unanimously.

There were no requests to address the Board.

CONSIDER:

Ms. Turner led the Principals in a panel discussion addressing the goals of the Strategic Plan.
